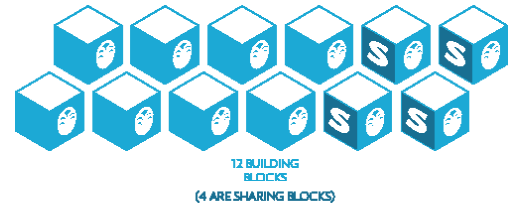

1. Start by submitting a **Letter of Intent (LOI)**.
2. Complete both cumulative and monthly requirements.
3. Complete a cumulative total of at least 12 Building Blocks, 4 of which must also be **Sharing Blocks**.
4. Complete a monthly minimum of 2 Building Blocks each calendar month to continue Qualification
5. Even if you complete Qualification in your 1st month, you must still complete all 12 Building Blocks, 4 of which must also be Sharing Blocks.
6. There is no monthly minimum in your final month of Qualification.
7. Finish Qualification anytime within 1 week to 6 consecutive calendar months.
