- STEP 4:** Record your measurements, body fat percentage, and weight in the ageLOC TR90 program guide.
- STEP 5:** Track your progress **daily** in the ageLOC TR90 program guide.
- STEP 6:** After following the ageLOC TR90 program as directed for 90 days, take a final full body picture and make sure the date of the photo is verified (e.g., photo date stamp or holding a copy of a newspaper with the date visible).

- The final picture must be taken as similar as possible to the initial picture.
